- Contract Term: This notice establishes contract(s) resulting from IFB #22IFB8097 for a period of one (1) year, from November 15, 2022 through November 14, 2023 inclusive. The Solicitation and the vendor's response, along with the South Dakota Vendor's Manual are made part of the vendor's contract by this reference.
- 2. Extension: The State may, at its own discretion, extend a contract for an additional two (2) months past the original contract expiration date. The State may renew this contract for up to four (4) additional one (1) year periods. Notice shall be given by the State to the vendor at least 60 days prior to the termination of the contract, and the vendor shall agree to such extension within 30 days thereafter, before such extension period shall become effective
- 3. Pricing: All Price increases will not be considered until the contract has been in effect for 90 days. Written requests for price escalation must be supported by dated manufacturer's printed price sheets or similar documentary evidence must support written requests for price escalation. This evidence must be presented to the Office of Procurement Management, and if approved, the new pricing will become effective immediately after date of approval. Price increases will be allowed for the actual cost of the price increase from the manufacturer to the supplier only and must be presented as a percentage of increase, which will be used to adjust vendor pricing to the State. Price decreases are acceptable on invoice(s) presented for payment. If the open market price of a specific contract item is under the vendor's price, the State reserves the right to purchase the lower priced product.
- 4. <u>Delivery:</u> The contractor shall furnish and deliver all of the awarded items of supplies, equipment, and commodities enumerated in the schedules and specifications, at the price and according to the terms and conditions, and of the kind, quality, and amounts and at the times specified in the schedules and

specifications. The supplies, equipment and commodities shall be delivered to the Director of the Office of Procurement Management or to such State Department or State agency as he shall direct and such delivery shall be made without cost to the State.

5. Restriction of Boycott Israel:

For contractors, vendors, suppliers, or subcontractors with five (5) or more employees who enter into a contract with the State of South Dakota that involves the expenditure of one hundred thousand dollars (\$100,000) or more, by submitting a response to this solicitation or agreeing to contract with the State, the bidder certifies and agrees that the following information is correct:

The bidder in preparing its response in considering bids submitted from qualified, potential vendors, suppliers, and subcontractors, or in the solicitation, selection, or commercial treatment of any vendor, supplier, or subcontractor, has not refused to transact business activities, has not terminated business activities, and has not taken other similar actions intended to limit its commercial relations, related to the subject matter of the bid, with a person or entity on the basis of Israeli national origin, or residence or incorporation in Israel or its territories, with the specific intent to accomplish a boycott or divestment of Israel in a discriminatory manner. It is understood and agreed that, if this certification is false, such false certification will constitute grounds for the State to reject the bid submitted by the bidder on this project and terminate any contract awarded based on the bid. The successful bidder further agrees to provide immediate written notice to the contracting executive branch agency if during the term of the contract it no longer complies with this certification and agrees such noncompliance may be grounds for contract termination.

- 6. In the event of the inability or failure of the contractor to furnish and deliver any item or items enumerated in the schedules and specifications at the time and in accordance with the terms and conditions therein provided, the Director of the Office of Procurement Management may contract for or purchase such supplies, equipment, and commodities in the open market and the contractor shall make good the excess over the price named in the schedule and specifications and the cost of such supplies, equipment, and commodities in the open market provided however, that the foregoing provisions shall not apply where other penalties for any default in the performance of the conditions of this contract are provided for in the schedules and specifications.
- 7. All orders shall be shipped F.O.B. destination. Deliveries shall be made at such time, place and in such quantities as shown on the Purchase Order. All items in common usage are to be shipped within 30 days from the date of purchase order. An additional 10 days will be allowed for back-ordered items when notification is given, in writing, to the ordering agency that the items are not available for immediate delivery.

- **8.** All delivery tickets, invoices and statements shall show the purchase order number, brand or trade name and State Item Number when applicable as shown in this contract. Invoices must be submitted in duplicate to the State Agency ordering the merchandise. DO NOT SUBMIT STATEMENTS OR INVOICES TO THE OFFICE OF PROCUREMENT MANAGEMENT AS IT ONLY DELAYS PAYMENT.

Item #1: Four regular issues of the standard portrait format at 9,000 copies each.

Item #2: One issue, the calendar is in landscape format with one hole drilled for hanging at 19,000 copies each.

Item #3: Four Kids edition issues in the standard portrait format at 13,000 copies each. These will be inserted into each of the regular issues, the remaining 4,000 will be boxed up according to the specs and sent to the Ft. Pierre Office.

The four regular issues are 40 pages plus an 8 page insert. The calendar issue is 28 pages. The magazine is one of the principle tools GFP uses to bring projects, plans and accomplishments to the general public. High quality production values are required.

Services to be performed:

The successful vendor will be required to provide excellent quality printing. Game, Fish & Parks will furnish the PDF file. The bid price includes a full color proof from cover to cover of each magazine issue. Proof to be mailed/shipped within 24 hours of receipt of files. There will be no additional charge for bleeds. The magazine contains a full-color, full-page insert in the center fold. The final product should be printed and postmarked for delivery no later than 14 days (including weekends/holidays) from final approval of materials. This is the case even if the artwork is delivered late; the vendor is still required to deliver no later than 14 days from the final approval of the artwork. Each issue the successful vendor will be responsible for inkjet addressing (no labels permitted), bundling, sorting and paperwork for delivery to printer's post office for each mailing. GFP will provide the mailing list by e-mail attachment or by upload to an FTP site. No overruns or overrun charges will be accepted. GFP will pay periodical rate for postage. The successful vendor will be responsible for drop shipping the calendar issue various quantities to various GFP office locations across South Dakota (list provided below). Balance of shipment to be trucked to 20641 SD Hwy 1806, Ft. Pierre, SD 57532. The Regular and Kids Digest will be sent to our Ft. Pierre office and also to our subscribers. Low grade paper will not be accepted lnk will be soybean ink. Trim size to be 8-3/8" x 10-3/4". The insert is a full-color 8 pages 8" x 10". 4 regular issues of the standard portrait format. One issue, the calendar, is in landscape format with one hole drilled for hanging. Binding to be saddle stitch. 3 stitches required. Covers (outside front and back) varnished or aqueous coated. Excellent quality required. Packaged boxes cannot weigh more than 35 lbs. and must only contain 80 copies per box. Kids Digest extra issues can have 400 per box. Packaged boxes of the calendar issue must only contain 100 copies.

Binding to be saddle stitch, 2 stitches required, an additional middle stitch on insert.

Packaged boxes cannot weigh more than 35 lbs. and must only contain 80 copies per box.

Shall include an inscription listing the publisher, number of copies published, and approximate cost per copy per SDCL 5-18D-15.

Quality Control:

All work must be of an extremely high standard and will be reviewed on a page-by-page basis by representatives of Game, Fish & Parks. GFP can request a press proof at printer's expense. Substandard work by the vendor will be returned for revisions at the expense of the vendor. If there is an error at the fault of the vendor and it is too late to reprint the project, the vendor may be required to reduce the print costs for the next issue by 2%-15% depending on the severity of the error. The vendor and GFP shall discuss the problem to come up with a fair price reduction.

Contract Provisions:

This contract will run from November 15, 2022 through November 14, 2023. A total of four issues will be printed during the outlined contract date. The vendor will be responsible for meeting all local, state and federal requirements for such contracts.

Clarification Points:

Clarification #1: The page count of the Kids Edition is 8 pages. This information is found in the Materials section.

Clarification #2: The binding to be saddle stitched, 2 stitches required, an additional middle stitch on insert. This information is found in the Materials section.

Clarification #3: All but the extra 4,000 Kid's Edition will be inserted into the regular Digest. The remaining 4,000 will get shipped back to Ft. Pierre. The mailing list varies, the balance of the shipment to be trucked to 20641 SD Hwy 1806, Ft. Pierre, SD 57532. This information is found under Services to be performed.
