MASTER PRICE AGREEMENT WSCA IFB# WSCA 7066, "PRICE AGREEMENT"

Government Entity: **State of South Dakota**

1. Scope: Eligible participants in this agreement include all South Dakota state government agencies and all political subdivisions of the State, including counties, municipalities, public school corporations and all officers, boards or commissions of the State of South Dakota.

Agencies of the State of South Dakota, institutions, and universities may make direct purchases of commodities on this agreement up to \$5000 per item, as long as the purchase is for an item that is not available on a statewide contract that has been established by the South Dakota Bureau of Administration, Office of Procurement Management. Purchases of items exceeding \$5000 must be processed through the Office of Procurement Management in accordance with the Local Purchase Policy.

All political subdivisions of the State, including counties, municipalities and public school corporations may purchase from this price agreement according to their own procurement guidelines.

2. Changes: No changes to the master agreement are required.
3. Lease Agreements: No lease agreement terms are authorized as part of this participating addendum. The South Dakota Bureau of Administration will review any requested lease arrangements on a case by case basis.

Terms and conditions inconsistent with, contrary or in addition to the terms and conditions of this Addendum and the Price Agreement or Contract Number, together with its exhibits, shall not be added to or incorporated into this Addendum or Price Agreement/Contract Number and its exhibits, by any subsequent purchase order or otherwise, and any such attempts to add or incorporate such terms and conditions are hereby rejected. The terms and conditions of this Addendum and the Price Agreement or Contract Number and its exhibits shall prevail and govern in the case of any such inconsistent or additional terms.
