

PARTICIPATING ADDENDUM
WESTERN STATES CONTRACTING ALLIANCE
Public Safety Communication Contract

1. Scope: Eligible participants in this agreement include all South Dakota state government agencies, institutions and universities and all political subdivisions of the State, including counties, municipalities, public school corporations and all officers, boards or commissions of the State of South Dakota.

South Dakota state agencies, institutions, and universities may make direct purchases from this price agreement if the total amount of the purchase does not exceed \$1000. Purchases exceeding \$1000 be routed through the Office of Procurement Management or as directed by the Bureau of Administration. A purchase order issued by the Office of Procurement Management will authorize the contractor to complete the procurement.

Terms and conditions inconsistent with, contrary or in addition to the terms and conditions of this Addendum and the Price Agreement, together with its exhibits, shall not be added to or incorporated into this Addendum or the Price Agreement and its exhibits, by any subsequent purchase order or otherwise, and any such attempts to add or incorporate such terms and conditions are hereby rejected. The terms and conditions of this Addendum and the Price Agreement and its exhibits shall prevail and govern in the case of any such inconsistent or additional terms.
