3. **MORATORIUM REGULATIONS APPLY:** All technology items purchased by state agencies from Sharp Electronics contract #021808-SP are moratorium regulated and require Bureau of Information and Telecommunications (BIT) approval and a purchase order issued by the Office of Procurement Management (OPM) before they can be ordered.
4. Agencies may work with the listed authorized dealer closest to their location to make purchases from this contract.
5. Lease or rental options available through the contract will be reviewed by OPM on a case by case basis.
6. OPM may discontinue the State's participation in this agreement at any time.
