The Bureau of Administration, Office of Procurement Management (OPM) is making the National Joint Powers Alliance (NJPA) contracts listed on this notice available to state agencies for the purchase of carpet, carpet tiles, and related services that are not available from other existing State contracts. **AGENCIES MUST CHECK STATE CONTRACTS FIRST BEFORE USING THIS CONTRACT FOR ANY PURCHASES.**
2. These contracts may include floor covering and other related products other than carpet and carpet tile. **This authorization to utilize these contracts is limited to carpet and carpet tiles.** Other floor covering products may be purchased from these contracts using small purchase procedures, which require two additional quotes for any purchase exceeding \$1000 and not exceeding \$10,000.
3. **These contracts are administered by the NJPA and are open to NJPA members.
