The Western States Contracting Alliance (WSCA) establishes a means by which participating state procurement offices may join together in cooperative multi-state contracting for the purpose of providing Managed Print Service.

- 1. Scope:** This Addendum covers the WSCA Master Agreement led by the State of New Mexico for use by State Agencies, Local Public Bodies and Native American Communities within the State of South Dakota. This entity has been authorized by the State Chief Procurement Official of the state within which it is located to use the WSCA Managed Print Services contract.
- 2. Participation:** Use of this WSCA Managed Print Services cooperative contract by state agencies, agencies of political subdivisions and Native American Communities authorized by an individual state's statutes to use state contracts are subject to the approval of the respective State Chief Procurement Official. Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.

Eligible participants in this agreement include all agencies, institutions, officers, boards, commissions and public universities of the State of South Dakota, and all political subdivisions of the State, including counties, municipalities and public school corporations within the State of South Dakota.

All purchases or leases made from this price agreement by agencies, institutions, public universities, officers, boards or commissions of the State of South Dakota are subject to moratorium exemption approval by the Bureau of Information and Telecommunications, and must be routed through the Office of Procurement Management or as otherwise directed by the Bureau of Administration. A purchase order issued by the Office of Procurement Management will authorize the purchase or lease.

Political subdivisions of the State of South Dakota may purchase directly from the Contractor according to their own procurement procedures.
