- 2. <u>Participation:</u> Use of NASPO ValuePoint cooperative contracts by agencies, political subdivisions and other entities authorized by an individual state's statutes to use **State of South Dakota** contracts are subject to the prior approval of the respective State Chief Procurement Official. Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.

Eligible participants in this agreement include all agencies, institutions, officers, boards, commissions and public universities of the State of South Dakota, and all political subdivisions of the State, including counties, municipalities and public school corporations within the State of South Dakota.

Moratorium exemption approval from the Bureau of Information and Telecommunications (BIT) may be required if the items contain software and or will be connected to a computer.

Institutions under the control of the Board of Regents may make direct purchases from this agreement using their own procurement guidelines.

Political subdivisions of the State of South Dakota may purchase directly from the Contractor according to their own procurement procedures.

The Contractor may, at the Contractor's discretion, extend pricing from this agreement to Indian tribal governments and non-profit organizations in South Dakota. Any sales made to Indian tribes and non-profit organizations from this agreement shall be included in any required reports and shall be subject to the NASPO Valuepoint administrative fee.

3. Participating State Modifications or Additions to Master Agreement:

Prohibited Items: All agencies, institutions officers, boards, commissions and public universities of the State are prohibited from purchasing oral medications under this agreement. This includes oral medications found in First Aid Kits. It is the responsibility of the agencies, institutions officers, board, commissions and public universities of the State to not purchase oral medications.
