The Contractor may, at the Contractor's discretion, extend pricing from the Master Agreement to Indian tribal governments and non-profit organizations in South Dakota. Any sales made to Indian tribes and non-profit organizations under this Participating Addendum shall be included in any required reports and shall be subject to the NASPO Valuepoint administrative fee.
