- 1. **Contract:** This contract from Sourcewell 121923 CDW is for a period from March 13, 2024, through February 27, 2028 inclusive. Contractor agrees, at the States sole discretion, to allow further extensions past the original contract expiration date. Further extensions may be made part of this contract upon mutual agreement of the parties.
- 2. Delivery: All orders are F.O.B. destination with all transportation and handling charges paid by the contractor. Deliveries shall be made at such time, place and in such quantities as shown on the purchaseorder. All items in common usage are to be shipped within 20 days from the date of purchase order. An additional 10 days will be allowed for back-ordered items when notification is given, in writing, to the ordering agency that the items are not available for immediate delivery.
- 3. **Contractor Information:** All delivery tickets, invoices and statements shall show the purchase order number, and brand or trade name, and State Item Number when applicable, as shown in the contract. Invoices must be submitted in duplicate to the State Agency ordering the merchandise.

 <u>DO NOT SUBMIT STATEMENTS OR INVOICES TO THE OFFICE OF PROCUREMENT MANAGEMENT AS ITONLY DELAYS PAYMENT.</u>
- 4. Purchasing Instructions: All purchases made by State Agencies under the Executive Branch and Institutions from this contract MUST be routed through the Office of Procurement Management or as directed by the Bureau of Administration and entered on the State's accounting system and should default when requisitions are created. Agencies must purchase the preapproved standardized Bureau ofInformation and Telecommunications items listed on the following pages; substitutions must be approved by the Office of Procurement Management.
