

### TEKNION LIMITED LIFETIME WARRANTY

Teknion will, at no cost to the original purchaser and for as long as the original purchaser owns a Teknion product, repair or replace with a comparable product, at Teknion's option, any part or product sold after January 1, 1995, which fails as a result of a defect in its design, materials or workmanship. For all purposes of this warranty the term "purchaser" is defined as the entity or individual acquiring a new Teknion product as the initial purchaser thereof either from Teknion or an authorized Teknion Dealer.

### Exceptions to this warranty include:

- Teknion warrants its standard Wood Casegoods and Wood Tables to be free from defects in material and workmanship for a period of 10 years, of single-shift service, from the date of delivery. Modified Wood Casegoods and Custom Wood products are warranted for a period of 5 years, of single-shift service, from the date of delivery;
- Lighting products and grommets, which are warranted for 1 year from the date of delivery;
- Teknion product with fabrics, which are warranted for 5 years from the date of delivery;
- Complements products (excluding Navigate, QuickShift, Complements and hiSpace Height-Adjustable tables and task lights), which are warranted for a period of 5 years from the date of delivery;
- Electrical components, which are warranted for 10 years from the date of delivery;
- Moving parts, which include glides, slides, casters, user-adjustable worksurface mechanisms, arms, and bases, which are warranted for 5 years from the date of delivery;
- Teknion warrants its seating products based on a single shift (40 hour week). Usage beyond a single shift (40 hour week) will result in a reduction of the warranty in proportion to the increased usage;
- Seating mechanisms for all seating products, unless otherwise stated, which are warranted for 10 years of single shift (40 hour week) usage from date
  of delivery;
- Pneumatic cylinders for all seating products, unless otherwise stated, which are warranted for 10 years of single shift (40 hour week) usage from date of delivery;
- Stacking Chairs and related accessories, which are warranted for 5 years from the date of delivery;
- Around<sup>TM</sup>, Nuova Contessa<sup>TM</sup>, Savera<sup>®</sup>XL and Variable<sup>®</sup> chairs are warranted based on multi-shift usage (24 hours per day, 7 days a week) as follows:

- Wood color, grain and stain acceptance which may occur due to the natural elements of wood;
- Marble, which is a natural product. Marble's soft and porous density makes it more vulnerable to damage and chipping;
- Ballast and light bulbs;
- Products which have been modified or which have not been installed or used according to Teknion's application and installation guidelines or warnings;
- Products that must be replaced due to normal wear and tear, negligence, abuse, accident or shipping damage;
- Products used for rental purposes.


### **VONDOM Warranty**

# Design for the **Environment (DfE)**

Sustainability is a cultural imperative within our company, embraced at both the corporate and individual levels.

### DFE GUIDELINES

DfE is a proactive approach to incorporate environmental attributes in the design process. It is proven to be an effective way to have a positive environmental impact. Teknion's DfE program is a set of 11 guidelines that cover a holistic view of the design process. First implemented in 2005, it remains the driving foundation for product development, through material selections and manufacturing processes. Our DfE guidelines were modeled from the Environmental Protection Agency. The following are Teknion's DfE guidelines:

- 1. Work with manufacturing and product engineering to utilize our integrated design process for the reduction of waste in all forms. Managed through ISO 14001.
- 2. Maximize use of materials with high recycled content or ability to be recycled.
- Maximize product design to enable rapid disassembly to base material recycling stream. Where plastics have been used provide appropriate label by material type for recycling.
- 4. Maximize the use of renewable materials.
- 5. Eliminate the use of toxic materials as listed by IARC (International Agency for Research on Cancer).
- 6. Provide or incorporate bio-based alternatives within product structure or substrate.
- 7. Provide sustainable wood-based alternatives as substrates or veneers that meet FSC standards.
- 8. Design product for extended life reuse, incorporating the ability to upgrade finishes and reconfigure or configure with modular component into a new useable form. Provide instructions for end-of-life management of products.
- 9. Ensure product meets as defined by SCS Indoor Advantage low-emission test standards.
- 10. Design for Durability/Reliability, ensuring products are designed and manufactured to provide a long, useful life and allow for repeated service.
- 11. At product launch provide all relevant attributes to show the product's environmental specifications.

### **Materials**

### RECYCLED CONTENT

Teknion products include both pre-consumer and post-consumer recycled material content. This includes major product components such as fabrics, steel, particleboard, and packaging.
