

## Invitation To Bid

Sealed bids will be received by the State Engineer on behalf of the South Dakota Game, Fish and Parks at the Office of the State Engineer, Joe Foss Building, 523 East Capitol, Pierre, South Dakota 57501-3182 until November 25, 2015 at 2:00 PM CT for labor and materials to Facility Improvements, Custer State Park, Custer, South Dakota, OSE# G2115--01X.

Bids will be received for mechanical, electrical, and plumbing systems and assorted finish packages for facility improvements at various locations within Custer State Park in Hot Springs, South Dakota. Scull Construction is acting as Construction Manager at Risk for this project. Multiple bid packages covering the building scope of work will be included. Individual bid forms in the bid documents will provide more specific scope of work descriptions.

Contractors Please Note: There will be an OPTIONAL prebid meeting at 1:30 PM MST on Wednesday, November 18, 2015. Contractors shall meet at the Outdoor Campus West in Rapid City. Each contractor shall be held to have examined the premises at the prebid meeting and satisfied himself as to the existing site conditions before submitting a sealed Bid. Prebid meeting attendance is optional for contractors to be responsible and their Bid to be considered.

Anyone requesting, reviewing, or copying Plans and Specifications for this project (such individual is hereinafter referred to as "bidder") agrees that they are doing so for the sole purpose of submitting a bid on the project. In consideration of the State of South Dakota providing such Plans and Specifications for the purpose of preparing a bid, Bidder further agrees:

- A. The Plans and Specifications are the sole property of the State;
- B. Any copies of the Plans and Specifications obtained directly from the State will be returned to the office of Perspective Inc. immediately after the State provides notice that bidder will not be awarded a contract, or thirty (30) days after the bid opening for the project, whichever occurs first;
- C. Any copies of the Plans and Specifications made by the bidder will be destroyed immediately after the State provides notice that bidder will not be awarded a contract, or thirty (30) days after the bid opening for the project, whichever occurs first;
- D. If bidder does not submit a bid, bidder will fulfill the requirements of B and C above on or before the date of the bid opening;
- E. The Plans and Specifications are to be used only with respect to this project and are not to be used for any other project or purposes other than preparing a bid for this project;
- F. The Plans and Specifications will not be disseminated to any person or entity for purposes other than obtaining pricing information without the express written approval of the state;
- G. All information contained in the Plans and Specifications is confidential; and
- H. Should the bidder disseminate the Plans and Specifications to an individual or entity for purposes of obtaining pricing information, the bidder will require that individual or entity to adhere to the terms set forth herein. The bidder, however, assumes no liability for the misuse of the Plans and Specifications by such third party or such third party's failure to comply with the provisions contained herein.

Should bidder be awarded a contract for construction of the project, bidder does not need to return or destroy Plans and Specifications until after completion of the project.

Each bid in excess of \$50,000.00 must be accompanied by a certified check, cashier's check or draft in the amount of 5% of the base bid and all add alternates and drawn on a State or National Bank or a 10% bid bond issued by a surety authorized to do business in the State of South Dakota and made payable to the South Dakota Game, Fish and Parks of the State of South Dakota.

The South Dakota Game, Fish and Parks reserve the right to reject any or all bids and to waive any irregularities therein.
