The Office of the State Engineer on behalf of the South Dakota Board of Regents is soliciting STATEMENTS OF INTEREST from firms interested in providing Construction Testing Services for the Hospital Renovation project.

The current Trojan Center is a 33,975 square foot building in the central area of campus. Remodel plans include extensive interior demolition and renovation and an addition of approximately 12,000 square feet. The scope of work will include construction testing services as required by the project plans and specifications and is expected to include:

- Earthwork.
- Cast-In-Place Concrete.
- Masonry.
- Structural Steel.
- Steel Joint Framing.
- Cold Formed Metal Framing.
- Foamed In Place Insulation.
- Fluid Applied Membrane Air Barriers.
- Penetration Firestopping.
- Joint Firestopping.

Statements of Interest should include at a minimum (shown with relative importance):

- (1) Specialized expertise, capabilities and technical competence as demonstrated by the proposed approach and methodology to meet the project requirements; 15%
- (2) Resources available to perform the work, including any specialized services, within the specified time limits for the project; 20%
- (3) Record of past performance, including price and cost data from previous projects, quality of work, ability to meet schedules, cost control, and contract administration; 20%
- (4) Availability to the project locale; 20%
- (5) Familiarity with the project locale; 15%
- (6) Proposed project management techniques; 5%
- (7) Ability and proven history in handling special project constraints; 5%

The anticipated project schedule calls for the construction phase to begin in June 2016 with completion in the fall of 2017.
