

Invitation to Bid

Sealed COMBINED bids will be received by the State Engineer on behalf of the South Dakota Board of Regents at the Office of the State Engineer, Office of the State Engineer - Hillsview Plaza, 3800 E Highway 34 Pierre, SD 57501 until 2:30 PM CT, April 28th, 2016 for School of Medicine Boiler Replacement at University of South Dakota, 414 East Clark Street Vermillion, SD 57069 - OSE# R0616--07X.


Phase 1 of the Lee Medical Boiler Replacement Project is to demolish and remove a 100HP Hurst Gas Fired Vertical Steam Boiler #1 including misc. piping, control and electrical items. The existing single boiler will be replaced with two smaller gas fired vertical steam boilers and connected into the existing steam piping system. The replacement boilers would require new electrical feeders, flue gas ductwork, breakers, piping, control valves, insulation, metasys (BACNet) monitoring, operational controls and modification to the existing boiler feed water heater pumps.

Bidders please note: There will an optional on-site pre-bid meeting on April 19 at 2:00 PM CT, at the Lee Medical Facility for information on the facilities call Ronald Thon at 605.677.9578 or email at ronald.thon@USD.edu. Each Bidder shall be held to have examined the premises at the pre-bid meeting and be satisfied to the existing conditions before submitting a sealed bid. Prebid Meeting is optional for all bidders, but it will be the only opportunity for bidders to visit the site prior to the bid opening.

Copies are also on file for viewing purposes at the Office of the State Engineer. Anyone requesting, reviewing, or copying Plans and Specifications for this project (such individual is hereinafter referred to as "bidder") agrees that they are doing so for the sole purpose of submitting a bid on the project. In consideration of the State of South Dakota providing such Plans and Specifications for the purpose of preparing a bid, Bidder further agrees:

- A. The Plans and Specifications are the sole property of the State;
- B. Any copies of the Plans and Specifications obtained directly from the State will be returned to the office of West Plains Engineering immediately after the State provides notice that bidder will not be awarded a contract, or thirty (30) days after the bid opening for the project, whichever occurs first;
- C. Any copies of the Plans and Specifications made by the bidder will be destroyed immediately after the State provides notice that bidder will not be awarded a contract, or thirty (30) days after the bid opening for the project, whichever occurs first;
- D. If bidder does not submit a bid, bidder will fulfill the requirements of B and C above on or before the date of the bid opening;
- E. The Plans and Specifications are to be used only with respect to this project and are not to be used for any other project or purposes other than preparing a bid for this project;
- F. The Plans and Specifications will not be disseminated to any person or entity for purposes other than obtaining pricing information without the express written approval of the state;
- G. All information contained in the Plans and Specifications is confidential; and
- H. Should the bidder disseminate the Plans and Specifications to an individual or entity for purposes of obtaining pricing information, the bidder will require that individual or entity to adhere to the terms set forth herein. The bidder, however, assumes no liability for the misuse of the Plans and Specifications by such third party or such third party's failure to comply with the provisions contained herein.
- I. Should bidder be awarded a contract for construction of the project, bidder does not need to return or destroy Plans and Specifications until after completion of the project.

Each bid in excess of \$50,000.00 must be accompanied by a certified check, cashier's check or draft in the amount of 5% of the base bid and all add alternates and drawn on a State or National Bank or a 10% bid bond issued by a surety authorized to do business in the State of South Dakota and made payable to the Board of Regents. The BOR reserves the right to reject any or all bids and to waive any irregularities therein.
