On behalf of the South Dakota Board of Regents and Black Hills State University (BHSU), the Office of the State Engineer is soliciting Statements of Interest for Architectural/Engineering services for the Lyle Hare Stadium, Expansion Planning and Design project located on the BHSU campus in Spearfish, South Dakota. A Design-Bid-Build delivery method is being used for this project.

The scope of work will include programming and design. Final design and construction administration services may be negotiated depending on design and project funding. The A/E team will need to work with the Black Hills State University faculty and staff during programming phase to determine design and construction parameters.

Firms wishing to be considered for providing professional services for this project should send a Statement of Interest that outlines their qualifications and experience for this project. Statements of Interest should include at a minimum:

- Specialized expertise, capabilities, and experience as demonstrated by the team's capabilities, and the proposed approach and methodology to meet the project requirements. (30%)
- Resources available to perform the work, including any specialized services, within the specified time limits for the project. Include resumes of all personnel, including sub-consultants who will be assigned to this project for the entire duration. (25%)
- Record of past performance, including price and cost data from previous projects, quality of work, ability to meet schedules, cost control, and contract administration. (15%)
- Ability and proven history in handling special project constraints. (10%)

- Proposed project management techniques. (10%)
- Availability to project locale. (5%)
- Familiarity with project locale. (5%)

A technical review committee will review the proposals to shortlist firms. Shortlisted firms will then interview for the building committee, who will make the final selection.
