

- 1. Contract Term:** This notice establishes contract(s) resulting from Solicitation # 221 for a period of one year, from April 1, 2015 through March 31, 2016 inclusive. The Solicitation and the vendor's response, along with the South Dakota Vendor's Manual are made part of the vendor's contract by this reference.
- 2. Extension:** The State shall have the option, at the State's sole discretion, to extend the contract(s) resulting from this Solicitation for an additional two (2) months past the original contract expiration date. The State may renew this contract for up to four (4) additional one (1) year periods. Notice shall be given by the State to the vendor at least 60 days prior to the termination of the contract, and the vendor shall agree to such extension within 30 days thereafter, before such extension period shall become effective.
- 3. Pricing:** Price increases will not be considered until the contract has been in effect for 180 days. Dated manufacturer's printed price sheets or similar documentary evidence must support written requests for price escalation. This evidence must be presented to the Office of Procurement Management, and if approved, the new pricing will become effective 30 days after date of approval. All prices quoted by the bidder shall be firm for the term of the contract. Price decreases are acceptable on invoice(s) presented for payment.
- 4. Delivery:** The contractor shall furnish and deliver all of the awarded items of supplies, equipment, and commodities enumerated in the schedules and specifications, at the price and according to the terms and conditions, and of the kind, quality, and amounts and at the times specified in the schedules and specifications. The supplies, equipment and commodities shall be delivered to the Director of the Office of Procurement Management or to such State Department or State agency as he shall direct and such delivery shall be made without cost to the State.
- 5.** In the event of the inability or failure of the contractor to furnish and deliver any item or items enumerated in the schedules and specifications at the time and in accordance with the terms and conditions therein provided, the Director of the Office of Procurement Management may contract for or purchase such supplies, equipment, and commodities in the open market and the contractor shall make good the excess over the price named in the schedule and specifications and the cost of such supplies, equipment, and commodities in the open market provided however, that the foregoing provisions shall not apply where other penalties for any default in the performance of the conditions of this contract are provided for in the schedules and specifications.

6. All orders shall be shipped F.O.B. destination with all transportation and handling charges paid for by the vendor. Deliveries shall be made at such time, place and in such quantities as shown on the Purchase Order.
7. All delivery tickets, invoices and statements shall show the purchase order number, brand or trade name and State Item Number when applicable as shown in this contract. Invoices must be submitted in duplicate to the State Agency ordering the merchandise. DO NOT SUBMIT STATEMENTS OR INVOICES TO THE OFFICE OF PROCUREMENT MANAGEMENT AS IT ONLY DELAYS PAYMENT.
8. **Unless otherwise indicated, payment for items on the contract(s) may be made with the South Dakota Purchasing Card (Citibank Master Card). State agencies may use the Purchasing Card when making purchases of \$1000.00 or less per transaction.**


This is a full package which includes customized Light Bar, siren, controller, all required vehicle specific mounting hardware, siren and radio interface.

The only difference in the two line items is the options contained in the Light Bar itself. All other equipment in the package will be the same for both packages.


In addition to the light bars that are specified below the dealer will be required to supply as part of the package:

- **Siren Speaker**, minimum of 100 Watts, minimum of 120db
- **Siren mounting bracket**, vehicle specific mounting bracket for Siren Speaker.
- **Strap Kit**, Vehicle specific light bar “strap kit.” Strap kits or hook on mount adapters are used to eliminate drilling holes in the roof of the vehicle and hold the light bar down.
- **Light bar bases or feet**, low profile design. The bottom of the light bar will not rise more than 3/8” from the roof of the vehicle to prevent wind noise and improve fuel mileage
- **Controller**, Full function controller with 3 position slide switch. Controller will be one unit that controls all light bar and siren functions in addition to having the availability for programming to control other SDHP supplied and installed equipment such as gun locks, interior lighting and headlight or taillight flashers. Controller will have a minimum of 18 programmable buttons or functions in addition to the slide switch for the above listed controls, sirens and other functions.
- **User Programmable light and siren control system.** The programmable control system will function as the “brain” for the entire system. The system will control not only the lights and siren but additional SDHP supplied equipment. For continuity and elimination of redundant costs the programmable light and siren control system will work with the SDHP’s current system which is the Whelen Justice light bar and Whelen CenCom Sapphire.
- **Radio interface.** Dealer supplied interface that ties current Motorola XTL 2500, XTL 5000 or APX 6500 radios to the above system eliminating the need for a separate public address microphone. The radio interface will work with the SDHP’s current system which is the Whelen Justice light bar and Whelen CenCom Sapphire.
- **Photo cell.** All light bars will contain a manufacturer installed photo cell for automatic dimming in low light conditions or providing full power to LED modules during daytime hours. The automatic dimming function will be able to be over ridden by the individual operator of the system.
- **Delivery to Pierre, SD.** Light bars will be delivered to 104 S. Garfield Ave BLDG D Pierre, SD 57501.
- **Dealer service.** The following conditions must be met by the light bar dealer
 - 1) Ability to perform all warranty work on the light bar or any portion of the emergency warning system.
 - 2) Ability to perform non-warranty work on the light bar or any portion of the emergency warning system.
 - 3) Technicians to complete installation of the emergency warning system in conjunction with other police equipment on any of the above listed vehicles, if requested by the South Dakota Highway Patrol. .
- **Warranty.** Manufacturer warranty on light bar.

Interior Emergency Warning Package:

This is a full package which includes:

- Whelen wide angle ION lighthead/ 3 per vehicle (1 red, 1 blue and 1 amber universal mount)
- Whelen Ion V/2 per vehicle (1 red and 1 blue surface mount)
- Whelen 10 head Inner Edge lightbar/ 1 per vehicle (4 red, 2 white, 4 blue), flashing or constant on takedowns
Inner Edge mounting system
- Whelen rear traffic director/TAD8RB/1 per vehicle
- Traffic director interior mounting system
- Whelen Cencom Sapphire Siren Control/ 1 per vehicle

- **User Programmable light and siren control system**. The programmable control system will function as the "brain" for the entire system. The system will control not only the lights and siren but additional SDHP supplied equipment. For continuity and elimination of redundant costs the programmable light and siren control system will work with the SDHP's current system which is the Whelen Legacy and Justice light bar and Whelen CenCom Sapphire.
- **Radio interface**. Dealer supplied interface that ties our current Motorola XTL 2500, XTL 5000 or APX 6500 radios to the above system eliminating the need for a separate public address microphone. For continuity and elimination of redundant costs the radio interface will work with the SDHP's current system which is the Whelen Legacy and Justice light bar and Whelen CenCom Sapphire.
- **Dealer service**. The following conditions must be met by the light bar dealer
 - 4) Ability to perform all warranty work on the light bar or any portion of the emergency warning system.

- 5) Ability to perform non warranty work on the light bar or any portion of the emergency warning system.
 - 6) Technicians to complete installation of the emergency warning system in conjunction with other police equipment on any of the above listed vehicles.
- **Warranty.** Manufacturer warranty on light bar.
