1. Scope: This addendum covers the **Remanufactured Biobased Toner Cartridge** contract led by the State of South Dakota for use by Missouri political subdivisions authorized by that state's statutes or entity ordinances to utilize entity contracts. Agencies governed by Chapter 34 RSMo are specifically prohibited from using this agreement unless specifically authorized by the Director of the Division of Purchasing and Materials Management of the State of Missouri.
2. Participation: Use of specific NASPO cooperative contracts by political subdivisions authorized by an individual state's statutes or rules to use state contracts are subject to the approval of the respective State Chief Procurement Official. Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.

4. Lease Agreement: Leasing was NOT included in the Master Price Agreement.


