

**WESTERN STATES CONTRACTING ALLIANCE (WSCA)

FOR SMALL PACKAGE DELIVERY SERVICES**

The State of South Dakota and United Parcel Service, Inc. (UPS)

This Participating Addendum will add the State of South Dakota as a Participating State to purchase from the WSCA Master Price Agreement, Number MA 065 with United Parcel Service, Inc.

1. Scope: This addendum covers Small Package Delivery Services for State Agencies, political subdivisions and entities.

Eligible participants in this agreement include all agencies, institutions, officers, boards, commissions and public universities of the State of South Dakota, and all political subdivisions of the State, including counties, municipalities and public school corporations within the State of South Dakota.

The contractor may, at the contractor's discretion, extend pricing from this agreement to Indian tribal governments and non-profit organizations in South Dakota. Any sales made to Indian tribes and non-profit organizations from this agreement shall be included in any required reports and shall be subject to the WSCA administrative fee

(1973), and under the antitrust laws of the State of South Dakota, SDCL 37-1, and amendments thereto, relating to the particular goods, services and materials purchased by the State of South Dakota in connection with this contract.


