Below are the provisions that accompany the issuance of a SD State CAPITOL ACCESS PASS:

- The CAPITOL ACCESS PASS is valid until December 31 of the year it was issued.
- All applicants for a CAPITOL ACCESS PASS must consent to a SD background check.
 If you have a felony conviction on your record, you will not be issued a CAPITOL ACCESS PASS.
- When you enter the State Capitol, you must enter the security screening room located near the north entrance.
- Upon entry, you may present your CAPITOL ACCESS PASS to security personnel which may allow you to bypass security screening operations and immediately enter the State Capitol.
 - *At any time, a person in possession of the CAPITOL ACCESS PASS may be subject to screening operations at the discretion of security personnel.
- If you are granted a CAPITOL ACCESS PASS and choose to carry a concealed weapon in the State Capitol, you must follow the provisions of SDCL 22-14. Failure to do so may result in the suspension or revocation of the CAPITOL ACCESS PASS.
- The following items are prohibited from the State Capitol unless otherwise allowed by state law: firearms, ammunition and knives over 4 inches long, when measured in a straight line extending from the tip of the blade to the forward-most aspect of the handle (certain ceremonial knives may be allowed), alcohol, illegal drugs, fireworks, other incendiary devices, and other items that could compromise the safety and security of the State Capitol.
- If you misplace or lose your CAPITOL ACCESS PASS, the SD Highway Patrol must be immediately notified at (605) 280-4715.
- Sharing the CAPITOL ACCESS PASS with another person is prohibited and will be grounds for suspension or revocation of the CAPITOL ACCESS PASS.
- State Capitol Hours of Operation during the legislative session are as follows:
 - o Monday to Friday 7:00 am to 7:00 pm (or when gaveled out)
 - o Saturday & Sunday 8:00 am to 5:00 pm

inderstand that any felony conviction will make me ineligible for the CAPITOL ACCESS ASS. I further understand that there is no means to appeal this decision and all decisions e final.
