Hi – thank you so much for allowing the delay. In reviewing the letter and the questions, I think the only one that really applies to municipal government is the "Average weekly, monthly and yearly cost for legal publications for governmental entities."

We really have no way to know this, but did ask cities to send us their publication costs in 2020 as we worked against the Newspaper's House Bill this session. Ninety one cities responded, representing about 1/3 of all cities, but 2/3 of the population within city limits. When I took those costs on a per-capita basis, it was about \$2 per person; multiplied by the total population within city limits, it comes to about \$1 million per year spent by municipalities on publication costs. That would divide to a little over \$83,000 per month, or \$19,000 per week.

I hope this helps, and please let me know if I am not understanding the information request and how the different questions would apply to municipalities.
