Sealed cost proposals will be opened publicly on March 19, 2025 at 3:00 PM CT at the Facilities and Services office on the campus of South Dakota State University.

Proposals will be received for the design and construction of a partially enclosed clear span monoslope building. The facility would consist of five 30'x40' open-air bays and one 30'x80' attached enclosed building, totaling approximately 8,400 square feet of covered area. The facility would be used for housing transient livestock and include animal penning, gating, agricultural curtains, waterers, site lighting, feed aisle, sediment basin, and a manure collection bin. Be aware any public improvement must be designed by a licensed Architect/Engineer, licensed in South Dakota, per SDCL §5-18B-45.
