The Office of the State Engineer, on behalf of the South Dakota Department of Transportation, is soliciting Statements of Interest from firms interested in providing professional design services for the project referenced above. The project scope will involve the design, bid, and construction of New E30 Fueling Stations at various DOT fueling sites statewide. Construction shall include new underground E30 fuel tank along with new dispensers tied into existing fuel monitoring system. A few sites shall include replacement of existing gasoline and diesel fuel tanks and dispensers. Attached is a list of E30 sites. Each site shall be bid as a separate project. All sites will need to be completed by December 31, 2020.

The total construction budget for the project is \$1,950,000.00, but be advised that this number is subject to change.

Firms desiring to be considered for providing professional services for this project should send a Statement of interest that outlines their qualifications and experience for this project. Statements of Interest should include at a minimum:

- Specialized expertise, capabilities, and experience in Construction of similar facilities; technical competence as demonstrated by the team's capabilities, and the proposed approach and methodology to meet the project requirements. (30%)
- Resources available to perform the work, including any specialized services, within the specified time limits for the project. Include resumes of all personnel, including sub-consultants who will be assigned to this project for the entire duration. (30%)
- Record of past performance, including price and cost data from previous projects, quality of work, ability to meet schedules, cost control, and contract administration. (10%)
- Ability and project history in handling special project constraints. (10%)
- Proposed project management techniques. (5%)
- Availability to project locale. (10%)
- Familiarity with project locale. (5%)

A technical review committee will select the firm based on the criteria shown. The committee respectfully requests that statements of interest be limited to 25 pages or less. This is not a requirement; merely a request.
